### REVISED COVID AND FLU VACCINATION QUESTIONS ON CAPACITY TRACKER

There are changes to the COVID and Flu Vaccination information captured within Capacity Tracker. These changes are anticipated to take place evening of 31<sup>st</sup> August 2021

For **Care Home and Hospice providers**, we will no longer require you to split out workforce vaccination levels by role type (nurses, care-giving staff, non-care giving staff) and instead only require you to update the total numbers of residents/patients, directly employed staff and agency/bank staff vaccinated.

**Home Care providers** will be required to update total numbers of staff who have face-to-face contact with people you support and let us know whether they have received their Covid or Flu vaccination.

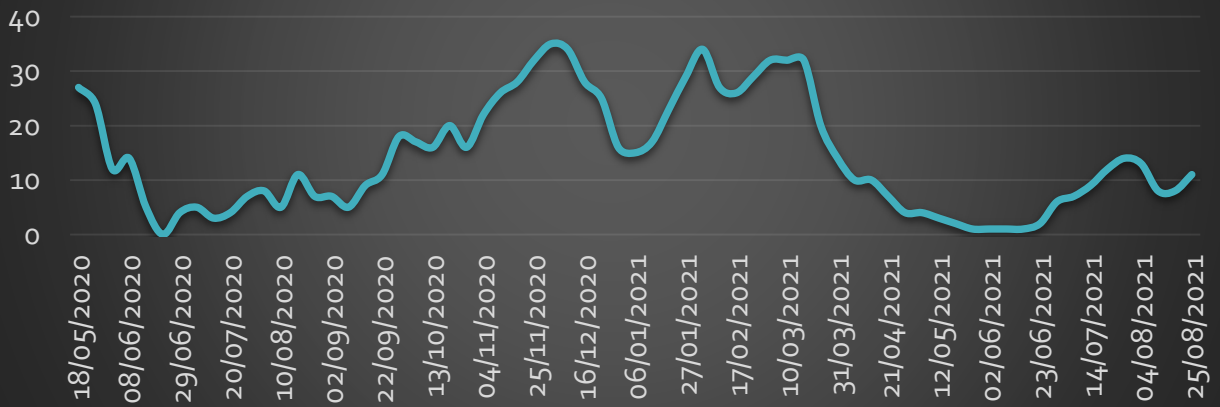

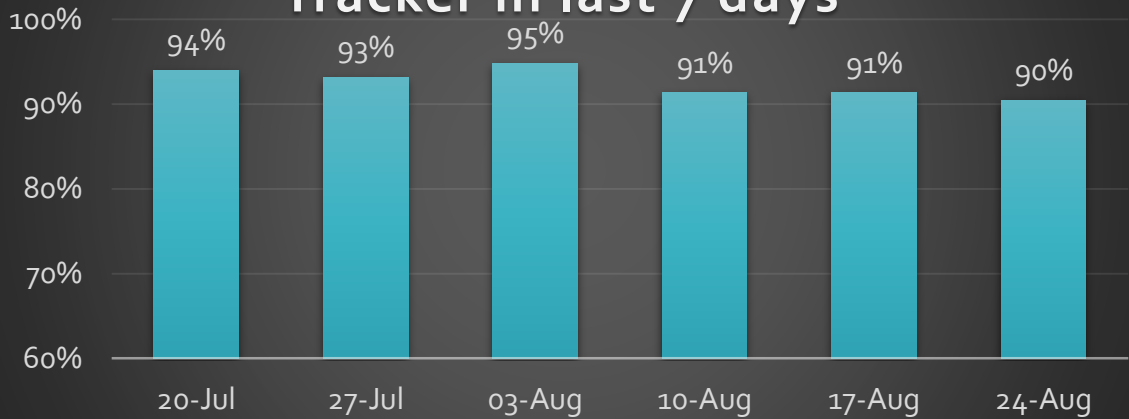
