## TEMPORARY EXEMPTION PATHWAY

The DHSC have confirmed that "On a temporary basis, from 15
September 2021, people working or volunteering in care homes who have a medical reason why they are unable to have a COVID-19 vaccine will be able to self-certify that they meet the medical exemption criteria, using the forms attached to this letter...

Once the NHS COVID Pass system is launched, care home workers will need to apply for a formal medical exemption through that process. This temporary self-certification will expire 12 weeks after the NHS COVID Pass system is launched."








### 15th September 2021 Inclusion North Coronavirus News


#### Plan A includes:
