We kindly remind providers to ensure they have updated their Adult Social Care data on Capacity Tracker. If providers need support completing or updating the system, accessing or using the reports and analytics, they can reach out either by phone 0191 691 3729 or via <u>necsu.capacitytracker@nhs.net</u>.

#### Top Tips (for providers)

- No annual re-set from 1<sup>st</sup> April 2024.
- Update/refresh Capacity Tracker as soon as the window opens; less reminders/saves time chasing!
- Attend training sessions to get a better understanding of the system & how to quickly update your information. June 2024: <u>Care Home Training &</u> <u>Homecare Training</u>
- **Peak holiday period** ensure arrangements are in place to complete updates as Capacity Tracker can not be updated from abroad.

#### A new service to provide discharge to assess from hospital into independent Residential and Nursing homes

City of Bradford Metropolitan District Council are commissioning a new service on behalf of the ICB to provide discharge to assess from hospital into the independent sector. The new service will provide people with a 4-week assessment period in a care home (nursing or residential) to support in determining their longer-term care requirements.

An opportunity to work in partnership to deliver safe and timely discharges from hospital into a care home, ensuring people have their needs assessed to enable them to receive the most appropriate long-term care placement and support.

# Revamp your RUSPECT discussions

· The classic "Not for CPR, Not for ITU" is practically useless outside hospital settings

- Try this structure to prompt patient-centred discussions and robust ReSPECT forms
- You don't have to do it all at one sitting, but get basic protections in place ASAP

| Re  | Resuscitation status; does your<br>patient need, and/or want,<br>the protection of a DNACPR?                                | Most frail patients <i>need</i> the protection of a DNACPR (in case series, survival after inhospital CPR is 0-2% in patients with a CFS of 5 or more), and some non-frail people <i>want</i> that protection too, if you ask them. |
|---|---|---|
| S   | Situations where admission<br>should be considered, or isn't<br>appropriate and/or wanted                                   | Where admissions should be avoided, include details of what <i>should</i> be done in the community. Ideally, include patient's preferred place of death (where appropriate)   |
| Ρ   | Possible treatments that should<br>be considered: e.g. a limited-<br>time trial of IV ABx? NIV?                             | Please <i>don't</i> use "admit for reversible causes<br>only" - paramedics tell us that doesn't help<br>them at all, as they can't prognosticate at<br>scene.   |
| E   | Existing co-morbidities and<br>functional baseline considered:<br>don't forget frailty, and prepare<br>for "ordinary dying" | Heart failure, renal failure, COPD and cancers<br>are examples where you need to consider<br>current impacts on patient, and likely disease<br>trajectory.  |
| С   | Ceiling of escalation clear:<br>what's the limit of intervention<br>appropriate for this patient?                           | This isn't just about ITU: think wider. Would NIV<br>be appropriate? If patient is in a Community<br>Hospital, should they be transferred back to an<br>acute site in event of deterioration, or not?                               |
| Τ   | Treatments that are likely to<br>be futile, inappropriate, and/or<br>that the patient doesn't want<br>- and why             | Specific treatment decisions should be tailored<br>to the individual patient. Ensure the patient/<br>family understand why these decisions are<br>being made.   |
| Final sense checks: where will this ReSPECT form be used? |   |   |

Final sense checks: where will this ReSPECT form be used? ReSPECT forms need to be able to help clinicians in a hurry at 3am on a Sunday morning - be that hospital teams, DNs, or paramedics. ReSPECT forms often need to be re-done for community use.
