# MANDATORY VACCINATION LAW PASSED - WHAT DO YOU NEED TO DO?

Yesterday the House of Commons voted to pass the regulations which will make two doses of a COVID-19 vaccine a condition of deployment in care homes. The regulations now need to go through the House of Lords, which should happen next week. Providing the Lords passes the regulations, the rules would then come into force 16 weeks later. # UPDATE TO INFECTION CONTROL AND TESTING FUND GRANT CONDITIONS

The grant conditions have now been updated:

- Costs to avoid public transport and accommodation costs are no longer a use of the direct funding for providers. This will remain part of the discretionary local authority funding.
- All testing costs (PCR and LFD) are to be met from the testing funding. Community care providers will be supported through the discretionary allocation of the testing funding with regards to PCR testing.

#### DATA COLLECTION IN CARE HOMES SURVEY

Data collection in care homes has become a really hot topic in the last year. Whether we think about the impact of the Capacity Tracker on care homes or the plans of the government to collect more data across adult social care as referenced in the recent <a href="Health-wedge-new-to-self-">Health</a> & <a href="Care Bill">Care Bill</a> and the government's <a href="data-strategy">draft data strategy</a> - now is the time to share your views.

#### HAVE YOUR SAY ABOUT DATA COLLECTION IN CARE HOMES

It is important to complete this survey because other countries specify a minimum set of data to be collected by care homes and there is growing interest in whether this would be a good thing for the UK to do.

#### We know that:

- There is a vast amount of data already collected in care homes and this survey is trying to establish what that looks like:
- There is a huge appetite for data from a wide range of key stakeholders who do not realise the breadth of data already being collected – we hope this will help to illustrate that:
- Much of the data from social care is already in other data sets so this will help to identify what is already known and where it goes;
- Data collected must provide mutual benefit for those providing it and those using it your views will help us here (see a <u>recent blog</u> about learnings from the Capacity Tracker).

This survey is part of a bigger study called <u>DACHA</u> (<u>Developing resources And a minimum data set for Care Homes' Adoption</u>) involving eight universities. The survey is being run from Newcastle University with support from the University of Kent and others. It aims to identify what data are already being collected, and help us understand how a minimum dataset would impact on workloads in care homes. The National Care Forum is also a partner in this study, as are other key stakeholders in the sector.

Only one survey response is needed per Care Home – but we need as many care homes as possible to respond **before the end of July**

## **VACCINATION AS A CONDITION OF DEPLOYMENT -CARE ENGLAND WEBINAR - 23 JULY 12:30-14:00**

Care England, in collaboration with Barchester Healthcare, will be hosting a webinar to provide support for adult social care providers following the Government's decision to make vaccination a condition of deployment in care homes. We are delighted to be joined by Professor Nicola Stonehouse, School of Molecular Virology at Leeds University, Dr Pete Calveley, Chief Executive of Barchester Healthcare, Genevieve Glover, Group HR Director at Barchester Healthcare, a representative from RadcliffesLeBrasseur LLP and we hope to be joined by a representative from the Department of Health and Social Care.

The webinar will provide an opportunity for adult social care providers to hear from Barchester Healthcare who introduced this policy into their own organisation for new starters in January and for all of their existing staff in April, following extensive engagement, communication and support. Nicola and the Barchester team will explain the approach they have taken to educate and inform Barchester's staff about the Covid-19 vaccination programme and their policy. It will also provide an opportunity to engage with sector leaders around any issues or concerns providers may have in relation to the policy.

#### TELEMEDICINE REVIEW


The workshop focused on Infection, Prevention and Control (IPC) and included:
