### **FLU IMMUNISATION LETTER**

Please read this <u>LETTER</u> from Direction of Public Health, Sarah Muckle and Clinical Chair, Dr James Thomas about the importance of vaccination against flu to help reduce pressures on the health and social care system this winter.

### **RED BAG PATHWAY**

A new date has been set to review the red bag pathway. It will now be on 24 January 2022 at 2pm, again via MS Teams.

The aim of the group is to discuss any areas of concerns with the red bag pathway and work together to make this the best that it can be, from both the care home and the hospital perspective. In the meantime, we urge you to send red bags in with people when they are attending hospital. Roshanne will send some communications out to Bradford Teaching hospitals staff to ensure they are correctly using them.

Prior to our next meeting in January, Roshanne will complete an audit to review all patients admitted from care homes in December, and make direct contact with the care homes that have not sent in a red bag with someone where they would have benefitted from one (just to see if there is a reason why they have not attended with one).

### **COVID-19 AND FLU VACCINATION WEBINARS**

Building on the success of the Covid-19 Vaccination Webinar workshops responding to vaccine hesitancy, we have commissioned a further round of workshops to support both Flu and Covid-19 winter vaccination campaigns.

### **Concept and Objectives**

There is concern that due to low flu circulation last winter and potential opinion that Covid-19 vaccination is more important, uptake of flu vaccination may not be as good as previous years. We also know that over 1 million adults in North East and Yorkshire are unvaccinated against Covid-19.

Vaccine hesitancy amongst eligible populations is a risk to population health and negatively impacts our poorest communities. The everyday conversations we all have are powerful, therefore the provision of skills training that uses the principles of Making Every Contact Count (MECC) and Motivation Interviewing (MI) can combat disinformation and myths while providing the necessary reassurance and confidence in safe and effective vaccines.

### The skills training covers:

How we can work together to build vaccine confidence, what we know and how this links to health inequality

Core skills and processes (OARS, Evoke-Provide-Evoke, Decisional Balance, and the 3As)

Skills practice – Building confidence in the vaccine

Resources that staff can use to respond to questions and concerns

The session will be interactive and include modelled conversations that showcase the core skills and processes being used. The application of this work can be far-reaching. Although this is focused on Flu and Covid-19 Vaccinations, these skills can be utilised for childhood immunisations, cancer screening and other health-promoting activities.

This provision has been funded by NHSEI as part of North East and Yorkshire Winter Vaccination Programme and will be delivered in partnership with Public Health England. Each workshop can cater for 30 people and lasts for 1 hour and 30 minutes. Please see link below for booking dates from **25 November to 9 December.**
