

Equalities Data Collection Questionnaire

Guidance for Managers in Provider Services

1. Introduction

Thank you for getting involved in the Equalities Data Collection Questionnaire initial roll-out.

The People Commissioning Service at Bradford Council have reviewed and designed a new approach to collecting equalities data.

We are asking all providers and all services to take part in this initial roll-out as it is important everyone is represented in the information being gathered.

We want to make sure all the services we commission are accessible, inclusive and responsive to the needs of people and communities within the District. This equalities questionnaire will help us improve existing services and shape our future services.

2. Background

Understanding who is using commissioned is important. It helps to shed light on the situation of groups who are at risk of discrimination and tackle inequality where it is happening.

At the moment, People Commissioning gather equalities data in two main ways:

- Through contract monitoring reports
- Through SystmOne

However, there are a number of issues with this, for example information is in different formats, some categories of data are missing, not all providers are asked to give the monitoring information and not everyone who uses services are recorded on SystmOne.

Over the last 18 months staff in People Commissioning, with support from providers and people who use services have reviewed how we collect and use equalities data from commissioned services.

In July 2024, with support from 9 providers across a range of service types, 277 people piloted our new equalities questionnaire and the approach we are using in this initial roll-out.

The initial roll-out is a census-type approach to give a baseline dataset for people using services in October 2024. After this initial stage, we will plan future roll-outs which will be different depending on the type of service

3. The questionnaire process

- Between <u>1st October and 31st October</u>, you are being asked to share the equalities questionnaire with everyone who uses your commissioned services in Bradford and support them to complete it where required.
- The questionnaire is available online only and the submissions will be sent directly back to the Council.
- Easy Read cards are available to support with completing the online questionnaire. Audio and BSL guidance on the questionnaire is also available.
- You will be sent an email with a link to the questionnaire and your unique service ID.
- > The questionnaires can be completed either,
 - By sending the link and unique service ID directly to the person for them to complete the questionnaire themselves, or
 - By a member of staff supporting the person to complete the questionnaire on a phone or tablet
- All responses are anonymous. The data will be linked to service provision, not individuals.

- If you hover over this symbol in the questionnaire you will be able to see a short explanation of why the question is being asked.
- All questions that offer answer choices have a prefer not to say option. All questions (apart from the unique service ID) can also just be left blank if people want to do this.
- If you already provide equalities data within your contract monitoring workbooks, you can decide to not do this for Quarter 3, and just use the equalities questionnaire in its place.

4. Results of the questionnaire

The questionnaire submissions will return directly to the council. In November the data will be transferred into a dashboard which will enable Commissioning and Contract Management staff to look at information received at a District, locality, service type or service level.

All providers will receive an individual report showing the results for their service. The report will also include prompts about how the data could be used, or where there might be questions to explore in more detail in services.

People Commissioning will also produce a wider summary report and action plan explaining what we found from the data and how it will be used to improve services going forward.
