### 10-MINUTE SURVEY – RECRUITING DISPLACED INTERNATIONAL CARE WORKERS

As part of a Yorkshire and Humber Department of Health and Social Care (DHSC) funded project, Bradford Council and the Bradford Care Association have been asked to support displaced international care workers to find alternative employment in our sector.

A displaced worker is a person working on a Health and Care Skilled Worker visa whose current Home Office Approved Sponsor (HOAS) employer has had their sponsor license revoked. Most recent figures suggest there may be circa 700 displaced workers in the Bradford area alone.

We would really appreciate and value your assistance with this by completing the following 10-minute survey by 13:00 Monday 23 September 2024. Your responses will help us build a realistic picture of how many potential vacancies exist across the Bradford area and help us ascertain any support needs for care providers interested in exploring becoming a Home Office Approved Sponsor and any challenges or barriers you may anticipate.

The WDF administered by Skills for Care is being scaled down in 2024-25. The Department of Health and Social Care has launched a new fund, the Adult Social Care Learning and Development Support Scheme (LDSS) for 2024 to 2025, the new fund will be administered by NHS-BSA.

Eligible adult social care employers in England can claim staff training costs from the Adult Social Care Learning and Development Support Scheme (LDSS).

The LDSS is available for non-regulated care staff, including deputy and Care Quality Commission-registered managers and agency staff, within the adult social care workforce.
