VISITING GUIDANCE FOR SUPPORTED LIVING SETTINGS

NATIONAL BOOKING SERVICE UPDATE

We are aware that eligibility for the National Booking Service (NBS) for Covid-19 Vaccinations has been changed.

Currently all Health and Social Care staff are unable to use the NBS, along with unpaid carers that are <u>not</u> receiving Carer's Allowance or registered with their GP Practice.

CLOSURE OF MARLEY FIELDS TESTING CENTRE ON FRIDAY 9 APRIL

Marley Fields testing centre was established early on in the pandemic last year. Its aim was to support adult social care staff and other critical key workers from the district at a time when the numbers of tests available was limited. The service continued to grow with during the summer and there were over 300 tests a day, on a 6-day week, being supplied to the social care sector.

As many of these primary services have moved to national or other local portals the demand for testing at Marley fields has significantly reduced. Based on this, the time has come to withdraw this service. Ironically one year from its inception Marley Fields will close on Friday 9th April and from that point there will be no testing available at the site. Current service users have been contacted and options and routes for testing have been discussed. During this period over 41,000 tests have been issued. A great example and achievement of collaborative work between health and council colleagues.

We would like to thank the many users of Marley Fields testing site. Particular thanks also go to all the different teams of staff that have been working to support the facility and make it a success including those form; the CBMDC Outdoor Centres; Nancy O'Neill and Sarah Worstead, and the different swabbing teams and all those present at the site.

NEW MENTAL HEALTH WELLBEING HUB

West Yorkshire and Harrogate Health and Care Partnership (WY&H HCP) has opened its staff mental health and wellbeing hub, supporting people who work in health, social care services and the voluntary community social enterprise sector (VCSE) as they deal with the impact of COVID-19.

Staffed by a dedicated professional team, the hub is a confidential, free of charge service funded by NHS England / Improvement that builds on existing wellbeing support that is available in hospital Trusts, councils and the many voluntary services organisations that make up WY&H HCP. The hub will provide a range of services, from intensive, individual treatment to resources that can support people to help themselves cope with feelings of bereavement, burnout, stress and trauma. EXTRA CARE AND SUPPORTED LIVING TESTING UPDATE: RAPID LATERAL FLOW TESTING NOW AVAILABLE TO SUPPORT VISITS IN AND OUT OF SETTINGS

Visits in and out of extra care and supported living settings can now be supported by rapid lateral flow testing. Both 'high risk' and 'wider' settings (as defined by the extra care and supported living testing risk-based criteria) will be able to order rapid lateral flow tests for this purpose.

Testing is one tool that can be used to help mitigate the risks to identify asymptomatic visitors who are likely to be infectious before they visit so they are able to self-isolate immediately.

Government to extend free COVID* PPE for health, social care and wider public sector services until the end of March 2022



Future of COVID PPE provision to health and social care, and wider public sector services secured



Ensuring additional free PPE will support the roadmap out of lockdown, whilst the vaccine programme continues to reach more people



Free COVID PPE scheme extended beyond previous end in June 2021

- The Government is extending the provision of free PPE to health and social care providers until the end of March 2022.
- Following the previous announcement of free PPE provision to . health, social care and public sector workers until the end of June 2021, the scheme will now be extended to the end of March 2022. as the expectation of clinical experts is that usage will remain high throughout the next financial year.
- In order to protect the health and wellbeing of health and social care workers, as well as their patients and clients, the continued provision will ensure frontline workers can access rigorously tested and high-guality PPE.
- PPE also plays a critical role in the wider COVID-19 response. such as enabling visiting to care homes and supporting emergency frontline services like the police, fire and rescue. Free PPE provision extends to all of these needs amongst public sector frontline workers.




