





Guidance on updating Care Home Staff /Agency COVID Medical exemption and COVID Vaccinations received abroad information

Care Homes are asked to answer the new questions shown below relating to Staff/Agency that have been added to the **Vaccinations** section of the **Cost, Vacancies and Business Continuity** page.

- Number of staff SELF-CERTIFIYING as medically exempt
- Number of staff in receipt of NHS COVID PASS MEDICAL exemption
- Number of staff self-certifying as being fully VACCINATED ABROAD

IMPORTANT NOTE: For care home staff/agency vaccinated abroad

COVID vaccination Information for Care Home Staff/Agency should now only be entered for those that have received a full COVID vaccination course e.g., Janssen vaccination just 1 dose = full vaccination course, Pfizer vaccination 2 Doses = full vaccination course etc.

Those Care Home Staff/Agency vaccinated abroad, who were previously recorded in Capacity

Tracker within COVID First and Second Dose information should now be removed from

these figures and either captured as point 1 below or excluded as point 2 and referred onwards for
further advice.

- 1. Received a full COVID vaccination course should be recorded in the new question field Number of staff self-certifying as being fully VACCINATED ABROAD.
- 2. Not received a full COVID vaccination course should not be included in Capacity Tracker COVID vaccination figures. Staff are asked to contact DHSC for further advice via capacitytracker-guidance@dhsc.gov.uk

The vaccination Section should be completed to reflect the new fields added and the guidance above. Those familiar with the Capacity Tracker system will observe revised wording to existing questions and layout within the vaccination section. The aim of these changes is to improve the flow, understanding and ease of updating the questions and reflect previous provider feedback.



Unable to save changes due to the errors on the page. Please correct the fields highlighted to allow your information to be saved.


Once corrected repeat the steps followed previously to save the page until the **Updates Saved** notification is displayed.

Flu/COVID Vaccinations Report



The Flu/COVID Vaccinations report has been updated to reflect the changes to information captured for Care Homes Staff/Agency vaccinations outlined within this guidance note.








The **Data Type** field is defaulted to **Numbers** but when clicked on then changes to percentages. An additional toggle button is then displayed relating to **Medical Exemptions** allowing a user to **Include** or **Exclude** Staff/Agency medically exempted within the % displayed. Clicking on **Include** will toggle selection to **Exclude** and vice versa. See screen shot below.

Medical Exemptions Included: when selected the Staff/Agency medically exempted are removed from the calculations consequently the percentage vaccinated for Staff and Agency staff increases.

Medical Exemptions Excluded: when selected the Staff/Agency medically exempted are included in the calculations consequently the percentage vaccinated for Staff and Agency staff decreases.



Report Download

The CSV download has also been updated with additional columns added to capture the new information. However, the report does not include percentage data.

Hospices do not capture the new information outlined in this guidance, therefore the new fields on any downloaded report for these provider types will be populated with a zero.
