## What do professionals need to evidence

- All professionals must have evidence of a negative Covid-19 test within 72 hours of the visit to the Care Home. Should there be no evidence, concern of the validity of the result or the professional not take part in regular testing, then an LFD test will need to be taken on the premises before the professional enters the care home.
- Any professional visitors to the homes as of the 11 November 2021 will need to provide evidence of their vaccination status using the NHS Covid Pass. This can either be confirmation of them having received the full course of the Covid-19 vaccination, or that they are exempt from receiving the vaccine.

## Information on testing

Please be aware that any staff who do not receive regular Covid-19 testing and who, as part of their work, need to visit a care setting, <u>OR</u> have not had their regular testing within the last 72 hours, must undertake a lateral flow test prior to their visit.

## What tests are available

- Polymerase chain reaction (PCR) tests are sent away to a lab to diagnose disease, these check for presence of the Covid-19 virus, which can be detected in the body before symptoms start and before antibodies form. In the lab a substance known as reverse transcriptase is used to increase the viral load within the sample so that it is easier to detect any presence of Covid-19 in the sample.
- Lateral flow tests (LFTs) can diagnose Covid-19 on the spot, but aren't as accurate as PCR tests, these also check for presence of the viral RNA, which can be detected in the body before symptoms start and before antibodies form. The sample is placed on an absorbent pad, as the sample flows through the pad it reaches a strip of antibodies, if there is Covid-19 proteins present, they attach to the antibodies and cause a reaction which confirms infection.
- Loop-Mediated Isothermal Amplification (LAMP) tests are a single-tube technique for the amplification of DNA and a low-cost, rapid alternative to the PCR. Instead of using a series of temperature changes to produce copies of the viral DNA, like a PCR test, LAMP is conducted at a constant temperature. Like RT-PCR, LAMP detects whether or not viral RNA is present in samples from a patient.

# What happens when a professional arrives at the home for a non-emergency visit?

Before entering the care home they will need to...

Present evidence of a recorded Covid-19 test, normally a Lateral Flow Test, with a negative result that has been carried out in the last 72 hours.

OR

Carry out a Lateral Flow Test on the grounds of the home before entering the building and for this test to come back negative.

AND

Use the NHS Covid Pass to present evidence their vaccination status.

OR

Recall the vaccination status from your records.

# How will a care home record vaccination status?

The care home might have a different method of recording vaccination status of professional visits, the method must comply with GDPR standards. Some systems that could be in use are:

- Paper records (which would need to be kept in a secure location)
- Verify Plus

The information that will be asked to record vaccination status will be:

- Full name
- Profession
- Organisation
- Vaccination Status (fully vaccinated or exempt)

No further information will be asked by the home to record vaccination status of a visiting professional. Should the home ask for more information than the above please use the escalation/reporting process contained within this document.

The above person is a registered participant in an authorised NIHR COVID-19 vaccine Clinical Trial and is therefore authorised by the Department of Health and Social Care to hold fully vaccinated status against COVID-19. This letter is provided because the standard NHS routes are not yet able to accommodate the technical details for those people who have achieved COVID vaccination status through a vaccine Clinical Trial.

The holder of this letter should be given equivalent status to someone who can demonstrate their full vaccination status through the COVID-19 status certification service for any future domestic use including pilot events.

Further details on the purpose of this letter can be found online in the letter from Government Deputy Chief Medical Officer Dr Jonathan Van-Tam on 11 June 2021, which notes that:

"The Department of Health and Social Care makes a firm commitment to all volunteers in formally approved COVID-19 vaccine trials in the UK that you will not be disadvantaged in terms of any future domestic vaccine certification, if introduced, compared to anyone else who has had their vaccines under the standard NHS programme."

By July 2021, all clinical trial participants should be able to demonstrate COVID status through the same routes as people who have had their status captured through the deployed vaccine rollout (e.g. for those resident in England the NHS App). For any future domestic use individuals will be able to obtain a Covid status based on vaccination, being tosted, having natural immunity (valid for up to 180 days after testing positive for Covid), participation in an NHR COVID-19 vaccine clinical trial, or being exempt from vaccination and testing on clinical grounds. In the interim, this letter is provided to NIHR COVID-19 Vaccines Clinical Trials participants to demonstrate equivalence to a vaccinated status.

## **Escalation and emergencies**

### What counts as a emergency?

It is the Registered Manager's responsibility to use their professional judgement to determine whether a situation is an emergency in line with the guidance <u>HERE</u>. Please note that you will need to record all decisions in relation to emergency situations, where people did not present their vaccination status.

Should the emergency staff be able to present their vaccination status, the incident will not have to be recorded. You will only need to log when evidence is not demonstrated.

### Who should you ask regarding categorising an emergency?

All responsibility to determine an emergency situation lies with the Registered Manager or the Senior on shift, their decision will be final.

What to do when someone who needs to evidence their vaccination status, but is unable to, tries to enter the home?

Refuse entry and request their details for follow up with their manager/team.

Telemeds or alternatives to someone carrying out an in person visit?

Remember to consider all options when needing support and whether or not a virtual visit or remote contact could assist with the situation at hand.

# REQUIREMENTS FOR VISITING PROFESSIONALS

## LEGAL REQUIREMENTS FOR PROFESSIONALS VISITING CARE HOMES

### VISITING PROFESSIONALS MUST PROVIDE EVIDENCE OF THEIR COVID-19 VACCINATION STATUS

We are committed to keeping people safe! If you are a professional visiting this care home, please make sure you can provide evidence of your Covid-19 vaccination status, otherwise you will be refused entry.

If anyone attempts to enter this care home without evidencing their Covid-19 vaccination status, we are required to follow a reporting protocol via The Covid-19 Support Team who will liaise with the person's line manager and Public Health at Bradford Council.

# **NO EVIDENCE! NO ENTRY!**

### YOU CAN ALLOW ENTRY INTO THE INDOOR PREMISES OF THE CARE HOME IF:

- They are a resident
- They can present their evidence using the NHS COVID Pass
- The Registered Manager has approved them for emergency assistance or maintenance (please ensure this is recorded and evidenced)
- They are a friend or relative of the resident they are visiting
- They are under the age of 18

AND THEY HAVE A NEGATIVE TEST

### YOU MUST REFUSE ENTRY INTO THE INDOOR PREMISES OF THE CARE HOME IF:

 Someone who needs to evidence their vaccination is unable to do so. Professional visitors <u>MUST</u> evidence their COVID-19 vaccination status. NO EVIDENCE, NO ENTRY!

Anyone who tries entering a care home without evidencing their COVID-19 vaccination status will be reported to the Covid-19 Support Team who will liaise with the person's line manager and Public Health at Bradford Council. Please ensure all refusals to entry are reported the Covid-19 Support Team.
