GUIDANCE UPDATE

For information the guidance on management of staff and residents following exposure to Covid-19 has been updated yesterday. No major changes, Just clarifies around some of the actions to take in line with changes which were brought in last week.

DIGITAL SECURITY PROTECTION TOOLKIT – (DSPT)

What is the DSPT?

The Data Security and Protection Toolkit (DSPT) is a useful guide and a free self-assessment tool that can support organisations to keep people's confidential information safe. It can also help to demonstrate that you're meets CQC expectations of good data security practice. The DSPT helps to evidence how you are protecting your organisation from and risk to cyber-attacks or breaches.

Once completed it will allow you to demonstrate to commissioners, GP's, CQC and other NHS services that you are handling information securely. There are some key fundamentals elements that the BCA will promote such as, GDPR compliance, ICO, NHS mail, best practice, preparatory work required and also the DSPT itself.

Purpose of the industry placement:

An industry placement gives 16-19-year-olds the opportunity to get a head start in their chosen career, through hands-on experience that benefits them and your business. Young people bring new ideas and a different perspective to the workplace, making them a fantastic addition to the team. In turn, they will learn invaluable skills and lessons that will help them when moving into the world of work.

How will it work:

Our industry placements are between 45 and 60 days. Ideally, the student will attend your workplace for 2 days a week, typically for 7 to 7.5 hours a day. The student you will take on will be studying a subject relevant to your business making them a valuable asset. They will have already developed some workplace knowledge, skills, and behaviours prior to the placement and will continue to do so throughout their time with you.

Immediate benefits to your organisation:

- Giving your employees the opportunity to develop management and mentoring skills
- Bringing new ideas and a fresh perspective to your business
- Corporate social responsibility impact: share with stakeholders how your business has supported local young people by improving their employability and progression opportunities.

Opportunities available:

T-Level Health Science qualification

The students on this course are academic learners looking to enter into a healthcare career or to progress into Higher Education upon completion of their T-level course. These students must not carry out any medical procedures but they can assist your teams with measurements such as blood pressure, heart rate, etc under strict supervision or provide assistance with general care work. Employers will receive a £1000 incentive to help with any initial setup costs. Start date: November

BTEC Health and Social Care

This is suited to students who want to become care workers and work within the health and social care sector. Start date: Mid-October or asap, for I or 2 days per week.

This week we highlight the accredited Safeguarding course available to both homecare and residential care providers free of charge via the Bradford Training Hub.

On this course your staff can discover that due to circumstances certain adults are considered at increased risk from abuse. By completing this course, your staff will develop greater awareness of common types of abuse and understand the role that they play in managing the risk.

They will learn to:

- Define safeguarding and describe common types of abuse and how they might occur
- Recognise possible signs of abuse
- Know the actions required if abuse is suspected
- Recognise the role staff play in managing the risk of abuse by promoting a positive culture based on respect, dignity and personal choice
