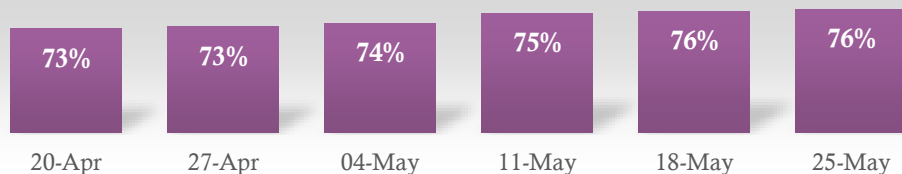

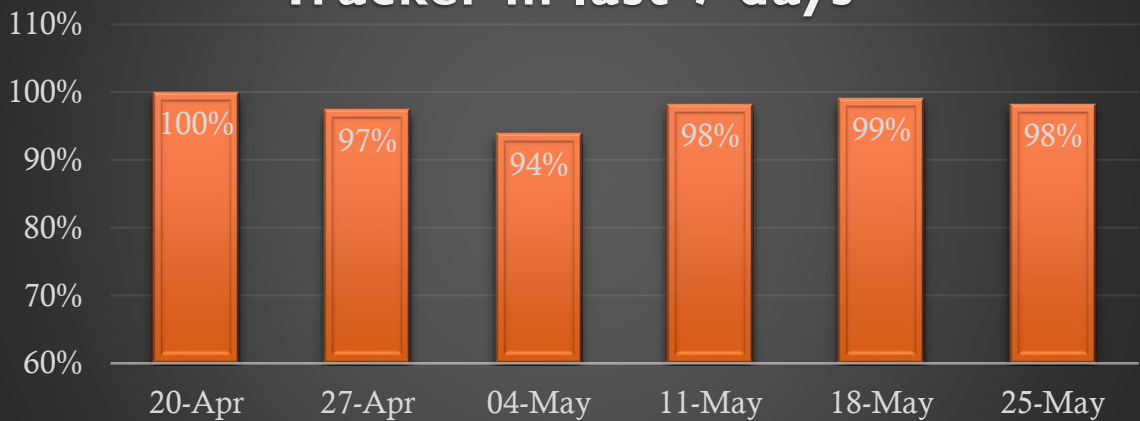
Bradford Care Home Occupancy Rate
