# HOW CAN THE NHS AND CARE ORGANISATIONS REDUCE POVERTY' BRIEFING PAPER

The Reducing Inequalities Alliance (RIA) has worked in collaboration with Bradford District Council's Anti-Poverty Co-ordination group to produce a briefing paper on how health and social care organisations within the Bradford District and Craven Health and Care Partnership can reduce the impact of poverty locally.

The effects of poverty on health are widely recognised; poverty makes it harder or less likely for people to access care, due to travel, available time or digital restrictions; stigma or lack of trust in services and low health literacy. Furthermore, in areas of deprivation, people are more likely to wait longer for non-urgent treatment and there are fewer GPs.

#### Actions organisations can take include:

- •Ensuring our communities and patient groups are involved in the co-production of services in order to understand and address barriers to accessing care;
  - ·Adopting inclusive employment practices; and
  - •Working with local schools and colleges in poorer communities (and with higher not in employment, education or training NEET rates) to offer family support, work experience and skills programmes.

# WARNING ABOUT OVERSEAS WORKERS AND INTERNATIONAL DRIVING LICENSES

When an overseas worker obtains a visa to work in the UK, if that worker has a driving license in their country of origin, this license is valid for 12 months in the UK.

There is no need to apply for an international driving license (although granted for 3 years this international license ONLY allows the person to drive in the UK for 12 months) - the driving license from their own country allows them to drive for 12 months - just the same.

After the 12 month period expires, the worker is <u>no longer insured to drive</u> - as they are driving illegally.

As an employer you should advise the worker as they enter the UK to apply without delay for a UK provisional license, have driving lessons and get their UK test passed to obtain a UK Driving License.

There are some exceptions to this rule, e.g. if a worker has a Nigerian driving license they can apply to DVLA for a UK driving license automatically - and actually can do up to 5 years after entering the UK.

BCA are awaiting detailed guidance from the CAA - and will share this as soon as possible.

# **eVISA COMMUNICATIONS PARTNER PACK**

The Home Office is replacing physical immigration documents with a digital proof of immigration status – an eVisa - for customers already living in the UK, and for new visa applicants too.

To prepare for this change, the Home Office has developed a suite of communications materials to help you share and embed eVisa messages across your channels.

All of these can be accessed using the links in this partner pack. This pack includes:

- An overview of eVisa key messages
  - eVisa overview factsheets
- eVisa guides for affected customers
  - eVisa social assets and posters

This partner pack will be routinely updated and supplemented by new materials throughout 2024 – please use and share them on your channels.

## NEW RIGHT TO WORK GUIDANCE FROM THE HOME OFFICE

A sponsored migrant is only able to legally complete additional hours in a skill shortage occupation role (e.g. care work), and these hours are in addition to and cannot contravene their core status and core sponsored work.

The employer that is engaging them on additional hours, is doing so within the restrictions of the sponsored rights to work - in others words **the** additional hours of employment entirely relies on the sponsored status.

In the event that the sponsorship licence is revoked and sponsorship comes to an end (at 60 days after the worker receives the UKVI letter informing them that their sponsor employer has had their license revoked) the worker no longer has the legal ability to work the additional hours, as this is linked to their core right to work under sponsorship. Therefore, the employer of the additional hours worker would not have any legal right to continue employing the worker on the additional hours.

The employer of the additional hours worker would need to complete new right to work checks and employ the worker on a new sponsorship visa (with full-time hours), or if this is not possible (as the employer has not got Home Office Approved Sponsorship) the employer must cease to employ them.

The home office is in effect closing this loophole of employment.
