NHS COVID PASS

RESTRICTING WORKFORCE MOVEMENT BETWEEN CARE HOMES AND OTHER SETTINGS

Guidance for care home providers on limiting staff movement between settings to help reduce the spread of COVID-19 infection has been updated. The revised guidance describes circumstances in which staff movement may be cautiously permitted to move to plan for capacity concerns and to ensure continuity of care. The guidance is available to read HERE.

SERIOUS INCIDENTS IN BRADFORD DISTRICT

Unfortunately we have received reports today of two very concerning incidents that we have been asked to share with all providers. One incident occurred in Bradford city centre and the other in Bingley, they are both detailed below.

SERIOUS INCIDENT IN BRADFORD

A serious incident has been reported to the commissioning team this afternoon. On Sunday morning around 6am, at the bus station in Bradford city centre, a man tried to pull a carer into a car while she was on her way to work, fortunately she managed to fight them off and run away but naturally we are extremely concerned by this incident and for the safety of other female staff in the Bradford district.

The incident is now being investigated by the hate crime co-ordinators in Bradford and is being treated as a racial hate crime.

The provider in question has issued all staff with panic alarms as well as putting in place no bed workers to work alone. We would recommend implementing similar policies within your service if possible.

SUSPICIOUS INCIDENT IN BINGLEY - UPDATE

Earlier today the Covid-19 Support Team sent out a flash email to all homecare providers about a suspicious incident in Bingley.

We have been notified by one of our provider colleagues, in the Airedale area, of a suspicious incident which occurred yesterday;

'We believe there may have been an incident yesterday with one of our clients in Bingley. Knock at the door, client answers and met by two men purporting to be plain clothes police (complete with radio / walkie talkie which they seem to be talking in to). They indicated that they were responding to a 999 call, to which our client said she hadn't rung 999, however invited them in, and allowed them to search the house. The client has full capacity.

Upon this being reported to us we have informed family who in turn contacted West Yorkshire Police and identified that no logs exist of any 999 call or officers responding to a 999 call in Bingley at that address. Unfortunately, no visual description (beyond two males with radio / walkie talkies) has been forthcoming due to reduced eyesight of client. The client's son is liaising with West Yorkshire Police.'

Please ask staff to be vigilant and to report any similar incidents to the Police.

West Yorkshire Police have now assigned a Police Inspector to oversee this case, and two Uniformed Officers are attending the client's home this morning to take statements and check the home over.

CAPACITY TRACKER SYSTEM UPDATE – BULK UPLOAD TEMPLATE CHANGES

Following on from the previous update, we are aware that some users are continuing to experience issues when making updates to the Capacity Tracker and/or some slowness when running reports. As part of the work to help improve the situation Capacity Tracker have made some changes to the bulk update and have separated the update into 4 sections:

- Updating vacancies and daily business continuity (includes covid vaccination, flu and PPE updates)
- ICF weekly/monthly questions
- Home Care Survey
- Updating contact information

Users of the bulk upload function should select the appropriate template to update their data.

Their technical teams continue to work on the current issues being experienced and thank all providers and wider stakeholder organisations for their patience. Capacity Tracker will continue to provide updates on the 'home' page of the Capacity Tracker.
