MESSAGE TO PROVIDERS FROM DHSC 20 JUNE: CAPACITY TRACKER

BULLE

Thank you for your continued sharing of data through the Capacity Tracker. This letter sets out the upcoming changes to data collection and provides detail on the information the DHSC will be requesting you submit via the Capacity Tracker from **31 July.**

From **July**, the DHSC will reduce the current collection from weekly to monthly in line with living with Covid policy and the DHSC commitment to keeping the data burden on you as light and as proportionate as possible

From the end of July, the government will be mandating the collection of the following data through the Capacity Tracker on a monthly basis for the remainder of this financial year (i.e., up to and including March 2023):

- Care home bed vacancies and Home Care service users
 Workforce resourcing including absences
- Vaccination, COVID-19 and (seasonal) flu including data relating to the coming autumns COVID-19 booster campaign
 - Visiting (care home) data

Providers will be required to update their data by the 14th day of each month or next working day ensuring data are no more than a week out of date. This means that the first set of monthly data will be due by 14 August.

In May, the DHSC discussed these changes at a series of data assurance sessions with yourselves. They have said they are very grateful for all of your feedback and engagement so far. CALLING ALL RESIDENTIAL AND NURSING CARE PROVIDERS IN BRADFORD!

Bradford Council, along with other local authorities across the country have responsibility for understanding the costs providers incur in delivering care in our local care homes and that this should be considered within the fee setting approach and process. In most cases, a local authority will set specific fee rates and will decide how to do this and what these rates are.

By the end of September this year Bradford Council will need to have undertaken a cost of care exercise for older peoples residential and nursing homes and completed a Market Sustainability Plan.

In order to ensure we correctly capture costs, we need your help.

The support we require will be in the form of information and data submission, essentially what you will have already to run your service. We anticipate the data collection submission will take a few hours.

We understand and appreciate how busy you are. For that reason, we will offer a contribution of £250 towards the costs of completing the submission, payable of full completion.

Cost of care best describes the actual costs a care provider incurs in delivering care at the point in time that the exercise is undertaken. It is typically presented as a unit cost for an hour of domiciliary care or a bed per week in a care home.
