MESSAGE FROM BETHANY PEARCE, ADULT SOCIAL CARE PPE POLICY DELIVERY LEAD, DEPARTMENT OF HEALTH AND SOCIAL CARE (06 OCT 2020)

A number of you have provided feedback about the proposed guidance change and your frustration at the process. I am writing again today to provide a fuller explanation of the change and reassure you that the Department and PHE take your concerns seriously.

Firstly, on behalf of DHSC and Public Heath England I apologise unreservedly for the confusion that has been caused by the sudden change in guidance. We are working to rectify this as soon as possible and are examining our internal processes to ensure that future revisions to the guidance go through the correct process.

The guidance was altered based on clinical health service requirements outlined within the 'COVID-19 Guidance for the Remobilisation of Services within Health and Care Settings' (this excludes Adult Social Care in England) which advises that vinyl medical gloves should only be worn in care situations where there is no anticipated exposure to blood and/or body fluids. This guidance was influenced by the findings of a literature review from Scotland which was based on clinical settings. This advice was subsequently applied to guidance relating to the Adult Social Care setting in such a way that it did not clearly delineate between personal and clinical care.

Taking on board the comments you have provided, we will be updating the guidance to make it clear that vinyl gloves can be used in the majority of situations where gloves are needed. Only when staff are likely to come into contact with blood should they wear nitrile, neoprene or latex gloves.

We understand, and are sorry, that this process has caused anxiety and frustration, in addition to having possible cost implications. We are endeavouring to amend the guidance quickly to provide clarity around the situation and to ensure the guidance is accurate and agreed.

INFECTION CONTROL FUND ROUND 2

The Council is preparing to allocate Round 2 of the Adult Social Care Infection Control Fund.

In order to be eligible for this round, the government has stipulated that:

- All home support, supporting living and extra care providers must have completed the CQC homecare survey for 2 consecutive weeks.
- All care homes must have completed the Adult Social Care (ASC) fund questions within the Capacity Tracker for 2 consecutive weeks. The <u>Capacity</u> <u>Tracker Care Home User Guide</u> can be accessed via this link. Step 4 of the document, page 17 onwards, details how to do this.

Please ensure that you are now completing these requirements, as we will require confirmation of this prior to distributing the fund.

We are working with representatives from Bradford Care Association and you will receive a further communication in relation to the fund in due course

XICKSTART SCHEME

Bradford Council is pleased to confirm that it will be acting as a Gateway for the Government's new Kickstart scheme. This means we can submit applications to the scheme on behalf of partner organisations who cannot meet the 30 jobs threshold that has been set nationally.

The scheme presents a fantastic opportunity for businesses to boost their workforce capacity whilst enabling young people to gain valuable, paid work experience by funding new posts for six months at national minimum wage for 25 hours per week. By acting as a Gateway we can maximise the number of local employers that can benefit from this scheme, and we are very pleased to be able to offer this service. I would be grateful if you could return as soon as is possible, or at the latest by noon on the 19th October 2020. We understand that there is a 30 day turnaround time at DWP once this is submitted so we hope to receive feedback on our submission by the end of November 2020.

ACS INFECTION CONTROL FUND CAPACITY TRACKER

There is a section on the Capacity Tracker called "ACS infection Control Fund" that has a series of questions to be completed and this needs to be updated once a week, as well as the daily updates that are required.

Updating the ACS section has been made a fundamental requirement for the Infection Control Fund which was received earlier this year and to be eligible for any subsequent funding. We therefore need to stress that it is important it is completed each week.

To access the ACS questions these are under the provider section. If you need more guidance to find these then the Contact Centre can help 0191 691 3729

The data across the whole of the Capacity Tracker and the ACS information is being scrutinised at a high level both regionally and nationally. As a Local Authority we are asked to report on specific entries by Care Homes, please be mindful that data submissions are an accurate reflection of the current situation at the home as entries may be queried. There is guidance under the help section about the full system if you are not clear about any part you are being asked to input. (Specifically the ACS section is under Care Home Support – Care Home User Guide – Page 17 – there is a further link to the ACS questions and guidance) but also now on the Provider Zone for ease.

The deadline for a full update of the Capacity Tracker, including the ACS Infection Control Fund questions, is Monday 12th October. Care Home Liaison officers will be contacting all homes to offer support- please make them aware if there are any issues meeting this deadline or email the Commissioning Inbox. Officers may also follow up if the system has not been updated by this time.

DELIRIUM IN COVID-19

Delirium is a sudden change or worsening of mental state and behaviour. It can cause confusion, poor concentration, sleepiness, memory loss, paranoia, agitation and reduced appetite and mobility.

As of the 2nd of October guidance was issued that the onset of delirium in older people, or in those with dementia or cognitive impairment should prompt clinicians to consider SARS-CoV2 testing.
