


Priority end-of-life journeys

Yorkshire Ambulance Service NHS Trust (YAS) provides timely transport for patients at the end of their life to their preferred place of care or death.

This service is available, free of charge, 365 days a year for palliative patients registered with a GP in Yorkshire and North Lincolnshire.

Our staff have received specialised training in caring for those with palliative needs and we help patients and their carers to their chosen destination without delay, reducing anxiety and ensuring everyone is treated with dignity and respect.



A priority EoL journey is defined as a patient who is believed to be at the end of their life and travelling to their home, hospice or hospital for EoL care or their chosen place to die.

Booking for an EoL journey can only be made by a healthcare professional. If you would like to make a booking, please call 0300 330 2000. Priority EoL journeys cannot be made online. The booking line is open 24 hours a day, seven days a week.

Please ensure that you make the call handler aware that you are making an end-of-life booking.

EoL journeys can take place on a weekend if capacity allows and no risk assessment is required. Otherwise, the journey will be prioritised for the following Monday.

BETTER SECURITY, BETTER CARE.

Key messages re 30 June 2023 deadline For ADASS and LGA

Deadline for adult social care providers' Data Security and Protection Toolkit publication: 30 June 2023

Adult social care providers should complete and publish their self-assessment of their data protection and cyber security arrangements for 2022/23 by **30 June 2023**, using the <u>Data Security and Protection Toolkit</u> (DSPT).

Local authorities are encouraged to make care providers aware of the deadline, and the free support available to complete the DSPT from the <u>Better Security</u>, <u>Better Care programme</u>. This includes help from 28 <u>Local Support Partners</u> across England, detailed guidance, a free helpline and targeted support to large provider groups with multiple services. The LGA, ADASS, NHS Transformation Directorate and NHS Digital are actively involved in the programme. This support will continue to be available after 30 June to enable care providers to review, update and republish their DSPT in the future.

All adult social care providers should complete the toolkit – including in-house services run by local authorities. <u>CQC</u> inspectors do encourage care providers to use the officially recognised DSPT and <u>LGA guidance for commissioners</u> as well as the new <u>What Good Looks Like</u> framework recommends councils require annual DSPT completion within their contracts with care providers going forward. If local authorities wish to include DSPT as part of a contract, there is <u>free wording guidance</u> from the Better Security, Better Care programme which was developed with North West ADASS.

If a care provider has an NHS contract to deliver services (e.g. a continuing healthcare contract) or if they use systems that access NHS patient data, to remain compliant they need to complete the DSPT on an annual basis.

The NHS Standard Contract - paragraph 21.2 states:

"The Provider must complete and publish an annual information governance assessment in accordance with, and comply with the mandatory requirements of, the NHS Data Security and Protection Toolkit, as applicable to the Services and the Provider's organisation type."

Reaching Standards Met on the DSPT also opens up access to take part in local shared records projects where these projects are available. The current DSPT information standard says:

"All organisations that have access to NHS patient data and systems must use this Toolkis to provide assurance that they are practising good data security and that personal information is handled correctly."



<u>Free webinar programme: Conversations about winter</u> vaccinations

The primary objective of the autumn booster programme this year will be to increase protection against severe COVID-19 disease for those at higher risk. In addition, there is an added need to address the inequalities in uptake of flu vaccination.

Low vaccine confidence amongst some eligible populations can present a risk to population health and more often negatively impact some of our poorest communities and/or risk groups. Our conversations our powerful, therefore the provision of skills training that uses the principles of Making Every Contact Count (MECC) and Motivation Interviewing provides staff with an important resource that can be utilised to combat disinformation and myths, whilst providing the necessary reassurance and confidence in what is a safe and effective vaccine.

The skills training covers:

- How can we work together to build vaccine confidence, what we know and how this links to health inequality
- Core skills and processes (OARS, Evoke-Provide-Evoke, Decisional Balance, and the 3As)
- Skills practice Building confidence in the vaccine
- Resources that staff can use to respond to questions and concerns

The session will be interactive and include modelled conversations that showcase the core skills and processes being used. The application of this work can be far-reaching. Although this is focused on winter vaccinations, these skills can be utilised for conversations about a range of other issues, for example, childhood immunisations, cancer screening, and other health-promoting activities

This provision has been funded by NHS Workforce Education and Training in partnership with the NHS Public Health Programmes Team Y&H.

Each workshop can cater for 30 people and lasts for 1.5 hours, dates available from the 23rd June 2023 to 31st August 2023 in preparation from the vaccine rollout which begins in earnest from September 2023. Please see further booking details and dates below.




