SUPPORTED LIVING: NEW GUIDANCE FROM DHSC (ENGLAND)

The government have issued new guidance for supported housing providers and staff in England.

This will assist with planning and preparation to reduce risks associated with COVID-19. It may also clarify how to apply other COVID-19 guidance to supported living contexts.

The guidance "is primarily for supported living settings, but many of the principles are applicable to extra care housing for older people. It may also be a useful resource for the wider supported housing sector, such as retirement or sheltered housing." Tuesday 11 August 2020
