SERVICES TO BE SUPPLIED: DISCHARGE TO ASSESS – PATHWAY 3.

INDEPENDENT RESIDENTIAL AND NURSING HOME BEDS

1.	BACKGROUND
1.1	<p>Our Intermediate Care (IMC) Blueprint for Bradford District sets out an ambitious plan to undertake a rapid transformation of intermediate care services.</p> <p>This will support us in going further faster towards delivering improved outcomes and services for our population.</p> <p>As part of this we are seeking homes to provide Discharge to Assess (DTA) beds into an Independent residential or nursing care home in the Bradford area under Pathway 3. This is to enable a period of assessments for individuals when Home is not an option, and the individual is likely to require long term care in a 24-hour bedded unit.</p>
1.2	<p>This delivery of this service is open to providers operating within Bradford District and who are registered on the Provider List.</p> <p>The Provider List provides the overarching Terms and Conditions</p>
1.3	<p>Sign up to this service is optional.</p> <p>A variation to the current contract will be issued following a successful application.</p>
1.4	<p>It is expected that there will be approximately 320 number of discharges a year, with assessments generally being completed within 14-28 days.</p>
2.	SERVICE REQUIREMENTS
2.1	<p><u>Provision</u> Please see '2.5 Enhanced Requirements for Discharge to Assess (DTA)' which sets out requirements under this service. This will run in conjunction with the documents under Bradford and District Residential and Nursing Care Homes Provider List BMDC/DN420609.</p>
2.13	<p><u>Timescales</u> The service will run from August 2024 until 31st December 2031 in line with the overarching Provider List.</p> <p>A review of this service will take place after approximately 6 months.</p>
3	PAYMENT ARRANGEMENTS

	Nursing 1089.76 p/week Payment will be calculated on a daily basis.
