#### THE RESIDENTIAL AND NURSING PROVIDER LIST CONTRACT

The Residential and Nursing Provider List Contract has been updated. Documents with a 2024 date in the title have been refreshed to include changes [any documents with a 2023 date in the title or no date have not been updated in this year's refresh]. The 2024 update includes changes to CQC terminology, as well as other system changes and a refresh of the Serious Concerns Procedure after a review of the policy. The Discharge to Assess Specification is also included, for those providers signed up to deliver this service. 

#### ALERT FOR CARE PROVIDERS! - DISPLACED WORKERS AND RIGHT TO WORK

Over a 4 week period from Monday 21st October, UKVI are sending out letters to all the displaced workers in Yorkshire and Humber to inform them that they have 60 days in which to find a new sponsor employer to allow the worker to remain in the UK.

[UKVI has not been writing out to displaced workers and there is now a 12-month backlog in the system where the worker may not know that their sponsor employer has had their sponsorship license revoked].

The YH International Recruitment Steering Group believe there may be over 5000 workers in YH involved in this backlog who may currently have no knowledge that their main sponsor employer has had their sponsor license revoked. But these workers will all be informed of this over the coming 4 weeks.


As a care provider you may currently be employing some of these displaced workers on the 20 hours additional time permitted by their sponsor visa. Once the worker receives the UKVI letter (in the next few weeks) and the 60-day period is over - you CANNOT employ the worker for the 20 hours as the worker then no longer have a right to work. Please see attached guidance document.

A Regional infrastructure involving a Regional Hub, 4 sub-regional Spokes and the 15 Local Authorities has been established (with funding from DHSC) in YH to help support these displaced workers and to try to match them to vacancies with new sponsor employers.

In Bradford, SkillsHouse will be undertaking this 'matching' service.

A process has been agreed with the DASS of each LA to send a letter of support to UKVI, to enable Home Office Approved Sponsors to quickly gain the Certificate of Sponsorship (CoS) for any displace worker who is being employed.

## New Right to Work guidance from the Home Office

A sponsored migrant is only able to legally complete additional hours in a skill shortage occupation role (e.g. care work), and these hours are in addition to and cannot contravene their core status and core sponsored work.

The employer that is engaging them on additional hours, is doing so within the restrictions of the sponsored rights to work - in others words the additional hours of employment entirely relies on the sponsored status.

In the event that the sponsorship licence is revoked and sponsorship comes to an end (at 60 days after the worker receives the UKVI letter informing them that their sponsor employer has had their license revoked) the worker no longer has the legal ability to work the additional hours, as this is linked to their core right to work under sponsorship. Therefore, the employer of the additional hours worker would not have any legal right to continue employing the worker on the additional hours.

The employer of the additional hours worker would need to complete new right to work checks and employ the worker on a new sponsorship visa (with full-time hours), or if this is not possible (as the employer has not got Home Office Approved Sponsorship) the employer must cease to employ them.

The home office is in effect closing this loophole of employment.

### WELLBEING NETWORK OPENS VIRTUAL HUB

The Wellbeing Network has now opened its Virtual Hub. The System Access Point (SAP) is a single point of contact for frontline workers to refer service users into the network. Our SAP staff will ensure that the person you referred is linked to the Hub that is right for them. The Network has three physical hubs: one in Thornbury, Manningham, and Tong. It can provide help and support with welfare benefits, loneliness/isolation, and mental wellbeing.

- 1. All ages\* and demographics can be referred.
- 2. Users of the service must be registered with GP practices in the Bradford District and Craven footprint or live within the local authority boundaries of the City of Bradford Metropolitan District Council and the footprint of the former Craven District Council.
- 3. The WBN has support for people with emotional/behavioural and social needs.
- 4. The WBN has support for people experiencing mild/moderate physical/ mental health needs including isolation/ loneliness.
- \*Please note that children (under 18) must be accompanied by an adult."
