# GOVERNMENT TO INTRODUCE COVID-19 VACCINATION AS A CONDITION OF DEPLOYMENT FOR ALL FRONTLINE HEALTH AND SOCIAL CARE WORKERS

The vaccination as a condition of deployment (VCOD) policy will now be extended to all health and care staff. The Secretary of State has just announced this in the House.

#### Key points:

- Staff working face to face with patients or service users will need to be vaccinated against Covid-19 in order to be deployed, unless they are exempt.
- Covid-19 boosters and flu vaccinations are not included in the policy scope.
- Once the regulations have been laid and approved in Parliament, there will be a 12-week grace period before the regulations come into force. Therefore, the policy is expected to come into force in April 2022.

This policy does not supersede, but sits alongside, the previously announced regulations requiring anyone working in a CQC-regulated care home to be vaccinated by Thursday 11 November. The operational guidance for this policy can be found HERE. The regulations that introduce VCOD across health and wider social care settings will include some amendments to the existing care home regulations. Once approved by Parliament, these amendments will take effect in the coming months:

- An unvaccinated new starter can be deployed in a care home 21 days after receiving one dose of an authorised COVID-19 vaccine
- Staff vaccinated overseas can be deployed but may need to receive a top-up vaccine dose, as per UKHSA advice. The government intends to run the self-certification process for people vaccinated in care homes until the end of the proposed grace period which is expected to be I April.
- Clinical trial participants will need to evidence their participation in order to be exempt from the requirement
- The definition of authorised vaccine will be aligned across the two policies

The group has been meeting throughout the pandemic.


We would like to thank you all for you are doing to support people across the District in what is a very challenging time for us all. We are committed to working together and supporting each other.

Services across the system are under severe pressure due to the level of requests for services /appointments and staffing vacancies and sickness. Yorkshire Ambulance service has been at its highest level of escalation for the past couple of months.GP practices as you will be aware are also under pressure. The acute hospitals and Care trust services are experiencing increased pressure also due to levels of Covid infection and backlogs of people waiting for assessment and treatment.

Adult Social care services in the Council are in the same situation as you will be as providers and we are having to prioritise hospital transfers and high risk assessments in the community for assessment/ support.

Staffing our services is an issue for us all. We thought we would let you know that you as providers are represented in our system discussions and we welcome your feedback and assistance. We are currently working together on updating our joint contingency plans for winter. Discussions which we hope you are involved in are ongoing.

We want to support you in implementing the Care Home legislation re vaccination of staff and visiting professionals which comes into force on the 11 November 2021. If you have any concerns or issues about visiting professionals or how things could be improved in working with you as partners, please let you COVID-19 Support Team Council Liaison Officers have details. We will liaise with our colleagues in the escalation group.
