#### CORONAVIRUS (COVID-19) TESTING FOR ADULT SOCIAL CARE SETTINGS GUIDANCE UPDATED 23 MARCH!

The guidance outlines the COVID-19 testing available for testing staff, residents and visitors for all adult social care settings.

Please see the following testing guidance for a range of specific adult social care settings:

- testing for adult care homes
- testing for extra care and supported living settings
- testing for homecare staff
- testing for personal assistants
- testing for day care centres
- rapid lateral flow testing of visitors in adult social care settings

Testing is an important part of the approach to help protect those in adult social care services, alongside infection control measures and proper use of personal protective equipment (PPE).

Vaccination offers vital protection, but no vaccine is 100% effective, and importantly we do not yet know if being vaccinated prevents transmission of the disease.

Therefore, testing and other infection control measures must continue to be used together to help keep care home residents, those who receive care and staff safe.




