#### NATIONAL BOOKING SERVICE UPDATE

From today, text messages will begin to be sent to people in cohort 11, starting with 38 and 39 year olds, inviting them to book their vaccination appointments through the National Booking Service. In line with JCVI guidance, the National Booking Service now allows people in this age group, without an underlying health condition, to book into an appointment offering an alternative to the AstraZeneca vaccine. The new NBS functionality will also enable pregnant women to book appointments at a site that offers the Pfizer-BioNTech or Moderna vaccine following a series of screening questions.

In addition, the self-declare function that allows frontline eligible health and social care workers to book through the National Booking Service has been re-enabled from today. This is in line with JCVI guidance and the Green Book:








