IMPORTANT UPDATES!

CARE HOMES

As you'll be aware the Council has recently identified some additional funding for care homes to continue to support your response to the pandemic:

- The Occupancy Support Scheme is up and running for care homes with occupancy below 75%. Period 2 ends this week application forms can be submitted until 06/12/2020 for this period.
- We'll be writing to you shortly about an additional contingency payment being made in recognition of the increased costs you have faced over the last few months. The expectation is that you will be able to use this money to flexibly manage cost pressures that have occurred, and that in providing this funding alongside the Infection Control Fund grant, your organisation will be in a position to financially protect staff needing to self-isolate due to a positive COVID-19 test or potential exposure to COVID-19 in particular the Council's Executive would like to see all providers using the funding available to support the payment of normal wages for staff self-isolating due to a positive COVID-19 test.
- Alongside this we have set aside an additional contingency fund to support services facing financial pressure from extremely high levels of staff self-isolation due to a COVID-19 outbreak.
- We will also be launching a grant process to enable you to access further Infection Control Fund money
 to specifically support visiting in Care Homes. We'll send out more information about this once the
 latest visiting guidance, including how testing of visitors will work, has been finalised

HOME SUPPORT, SUPPORTED LIVING AND EXTRA CARE

• We'll be writing to you shortly about an additional contingency payment being made in recognition of the increased costs you have faced over the last few months. The contingency payment will be made based on the number of service users you support who live in the Bradford Council district – regardless of how they are funded. The expectation is that you will be able to use this money to flexibly manage cost pressures that have occurred, and that in providing this funding alongside the Infection Control Fund grant, your organisation will be in a position to financially protect staff needing to self-isolate due to a positive COVID-19 test or potential exposure to COVID-19 – in particular the Council's Executive would like to see all providers using the funding available to support the payment of normal wages for staff self-isolating due to a positive COVID-19 test.

Guidance for seasonal decorations during COVID-19



Please follow your local advice on seasonal decorations in the first instance. Seasonal decorations can impede effective cleaning of the environment. During winter, there is an increase in cases of Norovirus, Flu, and Clostridioides difficile (C. difficile) and this year there is also COVID-19. Cleaning, as in all previous years, remains extremely important. We are aware you would like to ensure residents over the festive season are able to enjoy a cheerful atmosphere, without having an adverse impact on infection prevention and control. Therefore, the following guidance for seasonal decorations have been produced for you to consider:

- Decorations should be single season use and disposed of when taken down unless they are washable/ wipeable with a disinfectant which destroys C. difficile spores and is effective against COVID-19
- . Ideally, decorations should only be hung or displayed on walls, i.e. so they cannot be not touched
- Avoid putting decorations on horizontal surfaces, as this impedes thorough cleaning of the area.
 Decorations on horizontal surfaces should be minimal to facilitate enhanced cleaning
- Residents can display their own artificial Christmas tree and decorations in their room
- · No wood, straw or live trees should be used, artificial trees only
- · No cloth or knitted toys should be displayed
- No decorations should be displayed in clinical rooms
- Please note that if there is an outbreak of infection, e.g. C. difficile, Norovirus, COVID-19, in the home, all
 decorations may need to be disposed of

Following this guidance will help minimise the risk of infection, facilitate environmental cleaning, whilst ensuring a festive environment for your residents and staff.

External cleaning companies

If you use an external cleaning company, particularly for a 'deep clean', please ensure that they follow the guidance below:

- · First, clean with a pH neutral detergent solution, e.g. Hospec and warm water, or detergent wipes
- Then, disinfect using either:
 - A chlorine-based product at 1,000 parts per million, e.g. Milton, 50 ml in 1 litre of cold water; or
 - A virucidal product that is tested and conforms to EN testing standard EN14476; or
 - 0 70% alcohol wipes
- Alternatively, a 2-in-1 cleaning and disinfection product, e.g. Chlor-Clean, Actichlor-plus, Clinell Universal Wipes, can be used as a one-step method




