

Capacity Tracker Coming Soon

As a reminder of the communications sent 16 March 2023 the following changes will be taking place in Capacity Tracker in the near future

All Users

Due to the requirements of Cyber Essentials+ we are required to make changes to the criteria of the passwords used to access Capacity Tracker. Therefore, from the date of the next Capacity Tracker upgrade the following criteria will need to be applied to passwords.

- A minimum of 12 characters
- No previous password can be used
- Commonly used passwords or ones included on the National Cyber Security Centre list of breached passwords will not be permitted

The changes will be implemented in a phased approach, region by region, over the next 6-9-month period.

Provider Information

- Flu questions will be removed from Capacity Tracker when the Flu vaccination data collection is no longer required
- Data for the Covid Vaccination Booster will be requested for Care Home Residents
- Users of the Bulk Template update method will see the following amendments to the template to reflect the changes made. The yellow identifies the fields being removed and green indicates new amended fields.
