Dr Vanessa Taylor - DPSN, Registered Nurse, BSc, MSc Advanced Practice (cancer care), EdD, SFHEA

Following clinical roles in cancer and palliative care, Vanessa moved into higher education with a commitment to educate pre and post-registration health professionals about cancer, palliative and end of life care. Vanessa's activities and published work focus on: cancer, palliative and end of life care and education; evaluation of education and its impact on workforce development and clinical practice. As Chair of Steering Group/Lead Author for the Royal College of Nursing (RCN) Career and Education Framework for Cancer Nursing and Chair of Steering Group/Lead Author Health Education England (HEE) (Yorkshire and the Humber) End of Life Care Learning Outcomes, Vanessa has published unique resources that distinguish levels of knowledge, skills and practice for the workforce delivering care in these fields. These resources have informed practice and policy through membership of RCN Breast and Cancer Steering Group and HEE/Skills for Health Working Group for national end of life care learning outcomes.



Victoria Ali – BN (Hons) Adult Nursing, specialist practitioner qualification in Oncology, MA Medical Ethics in palliative care. Pg Cert Health Professional Education, FHEA

Through her clinical career Victoria has worked within Haematology and Oncology and following a role as Liverpool Care Pathway Facilitator moved into specialist palliative care. She worked as a palliative care specialist nurse within Sefton and Liverpool for nine years and subsequently as team leader for the community specialist palliative care team within Liverpool. Research dissertation - The role of compassion in healthcare within the assisted dying debate. Her main areas of interest are assisted dying, dementia and equity of care.

Victoria joined the University in 2018 as a lecturer in adult nursing. She leads the postgraduate end of life provision at the University and also teaches across both pre and post registration nursing courses. She is currently undertaking a PhD in Palliative care within the International Observatory on End of Life Care at Lancaster University developing upon her previous work relating to assisted dying.
