#### **NATIONAL MINIMUM WAGE IS GOING UP!**

Understanding what counts as working time is important to ensure you're paying the correct National Minimum Wage. Sometimes even employers who are paying above minimum wage rates can make a mistake leading to underpayment.

#### **COVID-19 VACCINATION AWARDS**

Following on from our previous Bulletin, please see below the current figures, collated from Capacity Tracker, for vaccination uptake in Care Homes.

Award	No. of Homes
Bronze	20
Silver	22
Gold	17
Platinum	11

For your home to receive their award, you must send an email to the Covid-19 Support Team with the following included:

- 1. Evidence of updating capacity tracker with your most up to date vaccination data.
- 2. If relevant, the number of people within your service that are not eligible for the vaccination and the reasons for this. We will not count these staff in your overall total, which may increase your level of award.
- 3. For staff that are eligible, but remain hesitant, please state their reasons why and any potential action you will be taking to mitigate the risk.

We will review your submission and award the relevant certificate to you. As previously mentioned, those that receive a gold or platinum award will also receive a letter of commendation from Iain Macbeath, Strategic Director of Health and Wellbeing, and Sarah Muckle, Director of Public Health, at Bradford Council.

There is no deadline for these awards and should your service become eligible for a higher award, we will issue your new award once the evidence stated above is submitted. For all other services, the team will contact you shortly via flash emails to support your award schemes, please be patient as we are staggering our approach as to not inundate the team with requests.

#### **ASYMPTOMATIC TESTING FOR PERSONAL ASSISTANTS**




