#### **Visiting Guidelines for Care Homes**

From Wednesday 2 September the Government has announced that local restrictions are being lifted for the following areas in the Bradford District:

- Worth Valley
- Craven
- Ilkley
- Baildon
- Bingley
- Bingley Rural
- Shipley
- Wharfedale
- Windhill and Wrose

For other areas in the Bradford District the local restrictions remain in place.

We continue to focus on how we can enhance quality of life and act in the best interests of all residents in conjunction with the most up to date infection prevention guidance and the Ethical Framework for Adult Social Care.

#### What this means for Care Homes:

If you are in a ward where local restrictions have been removed (i.e. those listed above) visiting arrangements can be reintroduced.

If you are in a ward with local restrictions: visits should remain limited to exceptional circumstances such as end of life care. Government guidance states visits from individuals who live in a ward with restrictions in place should not visit. In line with local and national guidance for visiting you must ensure appropriate, dynamic risk assessments are in place, personalised to the individual and flexible enough to reflect changing circumstances. This should include the use of PPE to maximise opportunities.

Staff living inside and outside of local lockdown areas can continue to travel in and out for work.

Current PPE and IPC guidance should be followed both in and outside the local lockdown areas.

# PPE PORTAL: HOW TO ORDER EMERGENCY PERSONAL PROTECTIVE EQUIPMENT

The PPE portal can be used by social care and primary care providers to order and receive critical coronavirus (COVID-19) personal protective equipment (PPE).

Providers who can use the service will receive an email invitation to register.

The Department of Health and Social Care (DHSC) has partnered with eBay, Clipper Logistics and Royal Mail to develop this service.

Orders will be managed in line with Public Health England (PHE) guidance and wider availability from the NHS Supply Chain's central PPE logistic operations.
