We are now at a critical time in respect of the Covid-19 virus with a rapid rise in infections, hospital admissions and case rates across the country and more locally here in Bradford. This significant increase in cases has been attributed to the **new variant of COVID-19**, which scientists have now confirmed is between **50 and 70 per cent more transmissible.** This is a real cause for concern for our care services

We ask that you continue to remind staff to work safely and adhere to all the IPC guidance and control measures to help stop the virus spreading.

We will continue to support you and your service to keep as safe as possible given we are at such a critical time in terms of the vaccine roll out and in a matter of weeks both residents and staff will have received their first vaccine, helping to halt the spread of the virus.

SUPPORTING STAFF USING LATERAL FLOW DEVICES





USEFULTIPS ON THE COVID-19 VACCINE FOR PEOPLE WITH DEMENTIA

The COVID-19 vaccination is being offered as a priority to individuals who are at highest risk of catching the infection and of suffering serious complications. This includes people living with dementia and those who have certain conditions that increase their risk of becoming seriously ill.

The vaccine is not compulsory but is highly recommended. If someone you care for has been offered the vaccine and they or their family are unsure about having it, recommend they seek advice from their **GP** or nearest health care professional and look at trusted sources as found **HERE**.

SUPER ROTA

The Super Rota ensures additional virtual GP support is available to residential homes when a resident is unwell. It allows Care Staff to report observations and seek support, This must be completed before 10:30 to access same day assessment and support. This was added to the Telemeds service at the start of Covid 19 Outbreaks.

This support is accessed using an iPad device and accessing the Telemeds team or by emailing the Digital Hub team. The email address is digital.carehub@nhs.net
