## IMPORTANT! DHSC LETTER ON UPDATED VCOD2 GUIDANCE

Please find attached a letter (inc. guidance) from Claire Armstrong, DHSC Director of Adult Social Care Delivery, which clarifies key information on the regulations relating to the extension of Vaccination as a Condition of Deployment (VCOD) to wider care settings and who the guidance applies to.

# LAUNCH OF THE DIGITAL READER



## How does Digital Reader work?

- This new tool allows users to take a photo of their LFT. The service uses artificial intelligence to determine the result of the test. Research has shown that this is more accurate than the human eye.
- The Digital Reader feature will appear in the Self-Report journey when you report your LFT results, and can be used to determine Positive, Negative or Void results.
- To use the Digital Reader there is no additional software to download.
- Use of the Digital Reader service is an optional step when using the self report journey.

# What do you need to do?

- Self-Report LFTs as normal
- Allow for recommended development time stated on the instructions for your LFT kit, then use the Self-Report service immediately
- Follow the on-screen instructions, which will ask you take a photograph of your test kit
- If you are unable to take a photo, then you can report the result manually and in the usual way.

NHS Track and Trace have produced a <u>guidebook</u> which details the changes to the digital single registration journey.
