Provider Briefing:

We want to draw to your attention that the Adult Social Care is undertaking a consultation on Community Care Charging.

This will not impact on Providers directly; however, it will impact on those people you provide non-residential services to. We want you to be aware of this consultation in case any people you are supporting raise it directly with you or your staff. They may be anxious and/or concerned. We would like to try to minimise their anxiety in as far as we can, so we are asking that you and your staff provide a consistent message if asked any questions. This message is set out below under the Community Care Charging Consultation heading.

We are also asking that you and your staff sign post to our webpage where there is more information, and a list of our engagement sessions which are also included at the end of this briefing.

We will be sending a letter to all people in receipt of non-residential services on 10th February. This will invite them to participate in the consultation and will set out for them what the financial impact of the proposed change is. The consultation lasts for 12 weeks and will end on 5th May 2025.

Community Care Charging Consultation

Bradford Council is commencing a consultation on proposed changes to the discretionary elements of the Adult Social Care Non-Residential Contribution Policy. Community Care Services help people who are disabled, have long term health problems or are elderly with adult social care eligible needs to live more independently in their homes and the community). They will have been assessed by a social worker and their eligible needs can be met in a variety of personalised ways e.g. by a service managed by the council or purchased by a direct payment received from the council.

Community Care Services include:

- Day care (unless provided as part of a package of residential care)
- Personal care
- Outreach support
- Supported Living services
- Time Out
- Extra Care Housing
- Direct Payments

Contributions towards the cost of Community Care Services are not charged if a person is:

- suffering from Creutzfeldt Jakob Disease
- in receipt of 100% Continuing Healthcare Funding
- receiving aftercare under Section 117 of the Mental Health Act

They should be aware if they are in one of these 3 categories.

When people start to receive this service, a financial assessment is carried out to find out what their income and expenditure is.

This financial assessment helps us work out the maximum amount they would need to contribute towards the cost of the care they receive.

When we work out how much people need to pay towards their community care services (like homecare and day services), through a financial assessment we use guidance provided by the Government.

The Government has set a national 'Minimum Income Guarantee' (MIG), which is an amount of money set by the Government that any individual must be left with to live on after their care charge is taken into account.

The Council's current policy allows older people and younger disabled people who use adult social care services to keep 25% above the basic levels of income support, which we call a discretionary buffer. This means that if basic levels of income support are £200 per week the Council currently allows people to keep £250 after their charge.

Bradford Council is proposing to remove this discretionary buffer, and we want to consult with those receiving community care services about this via a public consultation. A public consultation will help the Council to fully understand the impact that this proposed change may have on those receiving services.

If the proposed change goes ahead, their contribution towards the cost of their care would be in line with the national Minimum Income Guarantee and would still be based on their individual circumstances following a personalised financial assessment.

We are asking people about the proposed change through a public consultation. A public consultation will help the Council to fully understand the impact that this proposed changed may have on them.

No-one's charge will change until our councillors make a decision. The earliest any change would be made is 1 August 2025, and we would write to them again if any change is going to happen.

We would also need to complete a new financial assessment for them, including taking into account any Disability Related Expenditure, and to ensure they are

receiving all the welfare benefits from the Government that they or their household are entitled to. We can help them to claim these.

These new assessments will ensure any contribution they need to make towards the cost of their care is based on their most up to date finances.

What will happen next?

We have included in the letter some questions which they can return via Freepost for them to provide us with their thoughts on this proposal. They have 12 weeks, until 5th May 2025, to return this. Of course they do not have to participate in the consultation if they do not want to.

If they would prefer to speak to someone, attend a group discussion or respond by email, the attached information provides details of how to do that. We would like you to sign post them to these and our webpage.
