## **VACCINATION UPDATE**

Currently 13 people have Omicron in England. While scientists work to understand this new type of Coronavirus the government have announced they are offering the vaccine booster jab to more people.

#### This means:

- Everyone over 18 years who is entitled to a booster will be offered one before the end of January 2022.
- People will be invited for their booster earlier. This will be 3 months after their 2nd vaccine rather than 6 months.
- Boosters will be offered to those who are clinically vulnerable first. They will then be offered to people based on their age.
  - People with a particularly weak immune system, who have already had a booster, can get another one. We are being asked to wait until it is your turn for the booster. Do not try to book before this.

The Government has also said that children aged 12-15 years old will be invited for a 2nd vaccine, 3 months after having their 1st vaccine.

The new rules we updated you on earlier in the week still apply:

- People travelling from abroad must self isolate until they get a negative PCR test result.
- Anyone who has been in contact with someone with the Omicron type of Coronavirus must self isolate for 10 days, even if they have been vaccinated.
  - You must wear a face covering in all shops and on public transport if you can.

Ask someone you trust if you are unsure about how any of the changes affect you.

## CARE HOME VISITING AND THE OMICRON VARIANT.

As you are aware, last Friday there was a national update specifically around Care Home Visiting Guidance. This was compiled before the emergence of the Omicron variant.

The Guidance has been seen as setting a more relaxed tone to the way providers should approach visiting in their care homes.

## Michael Horsley Nurse Manager Infection Prevention at CBMDC has said today:

'Understandably there has been some nervousness amongst social care providers in relation to how they should interpret this guidance in light of new variant of Covid-19. We are aware that the Government is planning further updates to its guidance across a whole range of areas as further information is available on the Omicron variant. I am in regular contact with Sarah Muckle, Director of Public Health who is in agreement that at present we will support providers to continue to work to the guidance from 25 November until any updates are released. Providers should also bear in mind the changes to the national guidance in England on mask wearing and the strengthening of the messages on hand hygiene and social distancing. Visiting should continue to be supported in all care homes in accordance with the dynamic risk assessments providers have in place, the only exceptions being where homes are in an outbreak situation.

Providers should continue to communicate and consult clearly with their residents and family carers/visitors in relation to any changes to visiting protocols that reviews of dynamic risk assessments suggest. The Infection prevention and the Covid-19 Support teams will continue to support homes in any arising situations of concern. Any updates to guidance will be shared with providers as so as they become available'
